Copyright Law and Resources

European Union Copyright Law

- Artificial Intelligence (AI) Act, passed February 2024
- Copyright holders may opt-out of data mining systems
- Supports new licensing Eco-system

US Copyright Law

- [Copyright Law of the United States | U.S. Copyright Office](#)
 - Copyright Act of 1976 and amendments
 - Title 17 of United States code
- [The Digital Millennium Copyright Act of 1998](#)
 - Adopted to address theft occurring online during the birth of the internet age
 - Not updated to address AI
- Congress has drafts of legislation to Study AI
- White House posted a “[Blue Print for an AI Bill of Rights](#)”

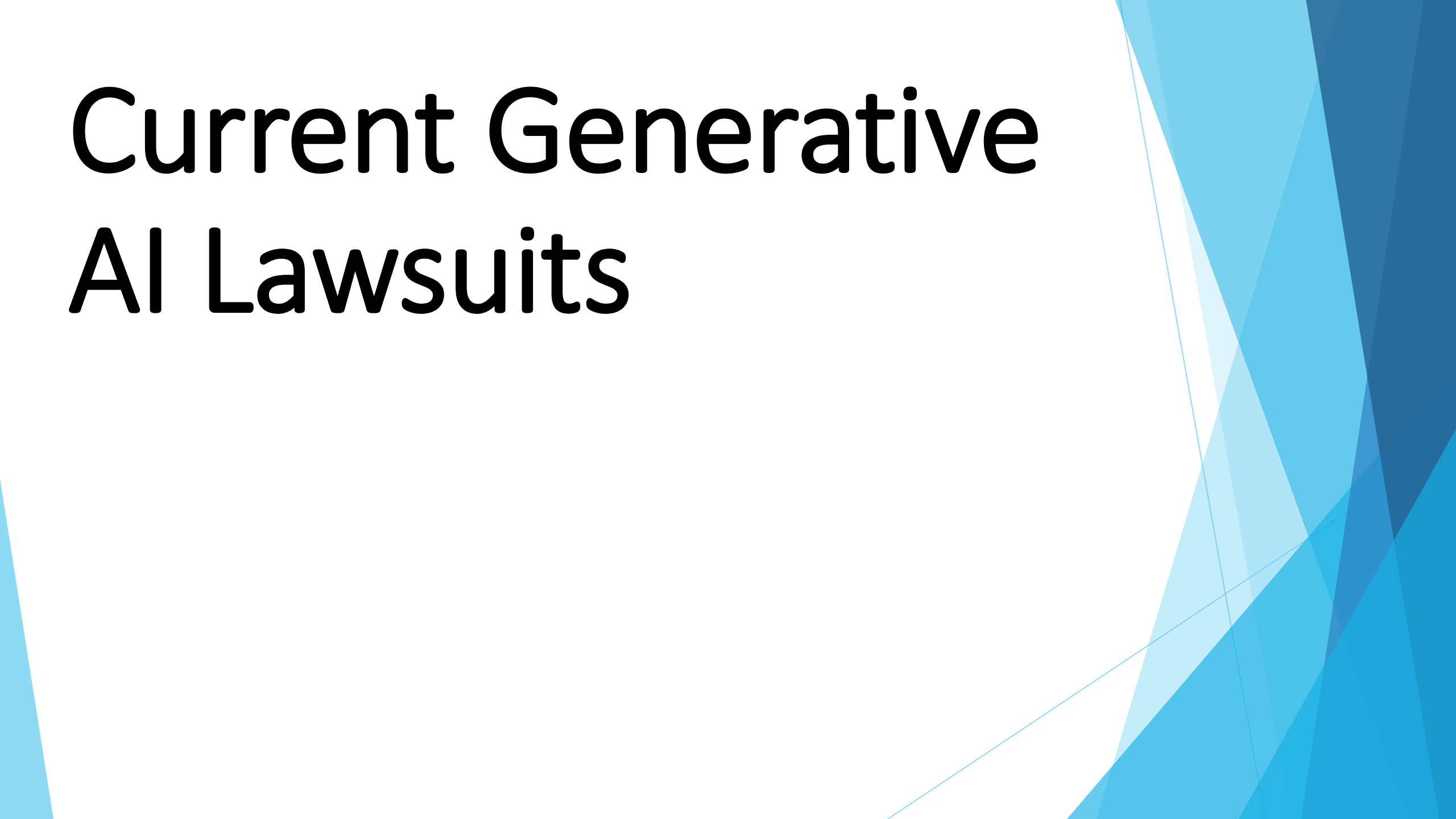
Copyright & Generative AI

Current Generative AI Lawsuits



The New York Times Company, plaintiffs, v. Microsoft Corporations, Open AI Holdings Inc.

- NYT Alleges
 - Articles used without permission and payment
 - Removed copyright management information and reproduced NYT's work verbatim
- Similar lawsuits filed
 - MediaNews Group and Tribune
 - News Corp filed similar suit against Perplexity in October
 - Raw Story Media
 - The Intercept
- All filed in Federal Court: SDNY

Authors Guild, et. al, plaintiffs vs. OpenAI Inc. defendants

- Class Action Lawsuit No.1:23-cv-8292 with a jury trial demanded filed in Federal Court: SDNY
- David Baldacci, John Grisham, George R.R. Martin, Jodi Picoult, Scott Turow and more
- “Generative AI threatens to decimate the author profession”
- Alleges
 - Illegal download without permission or consideration into LLM which outputs human seeming text
 - Algorithms are the heart of a commercial enterprise, and are thereby created via systemic theft on a mass scale
 - Creation of derivate works mimics, summarizes and paraphrases their works for commercial gain
 - Willful copying of copyrighted works. Training could have exclusive used works in the public domain.
- Defense
 - AI learn patterns from massive data sets and produce new media
 - Million of datapoints mean no replication of one person’s work occurs

Richard Kadrey, et al., v. Meta Platforms, Inc. Case No. 23-cv-03417-VC

- Class Action Lawsuit filed in Federal Court: NDCA
 - LLMA large language model meta AI lawsuit
- Sarah Silverman & Richard Kadrey are lead plaintiffs
- Two other cases consolidated into this trial
- [November 2023](#) – partial dismissal of claims in pre-trial motions.
 - Chance to amend claims
 - Upheld unfair competition claim (commercial profit without permission)

Getty Images (US), Inc. v. Stability AI, Inc.

- [Getty Images v. Stability AI – Complaint](#)
- Federal Court: District of Delaware
- Getty alleges:
 - Violates DMC
 - Theft of 12 million images and associated metadata from their database
 - Copied the database and created smaller versions to take up less memory
 - Violation of terms of use which expressly prohibit reproduction for commercial purposes
 - Images generated by products contain their watermark
 - Including in grotesque images which damage their company's relationship
- Judge found document production by Stability AI was incomplete & inaccurate
 - Claimed no work on product was done in UK
 - Media statesmen from 2022 by CEO discussed UK residency applications for Russians employees
- Stability AI, Inc. is attempting a forum non conveniens (FNC) argument and motion for summary judgment
 - Defendants want California courts for a better outcome

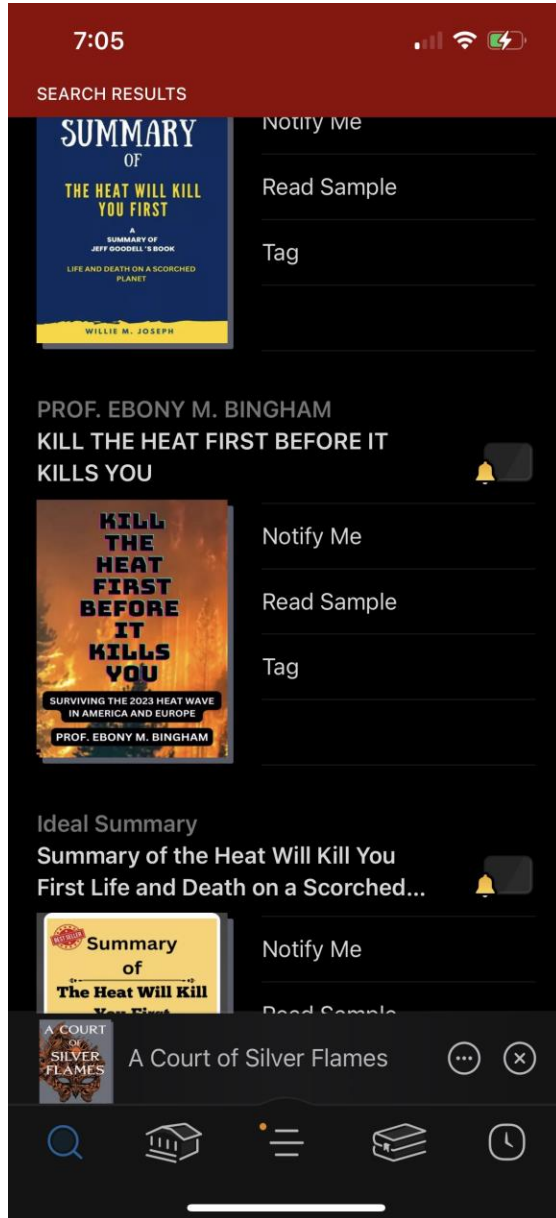

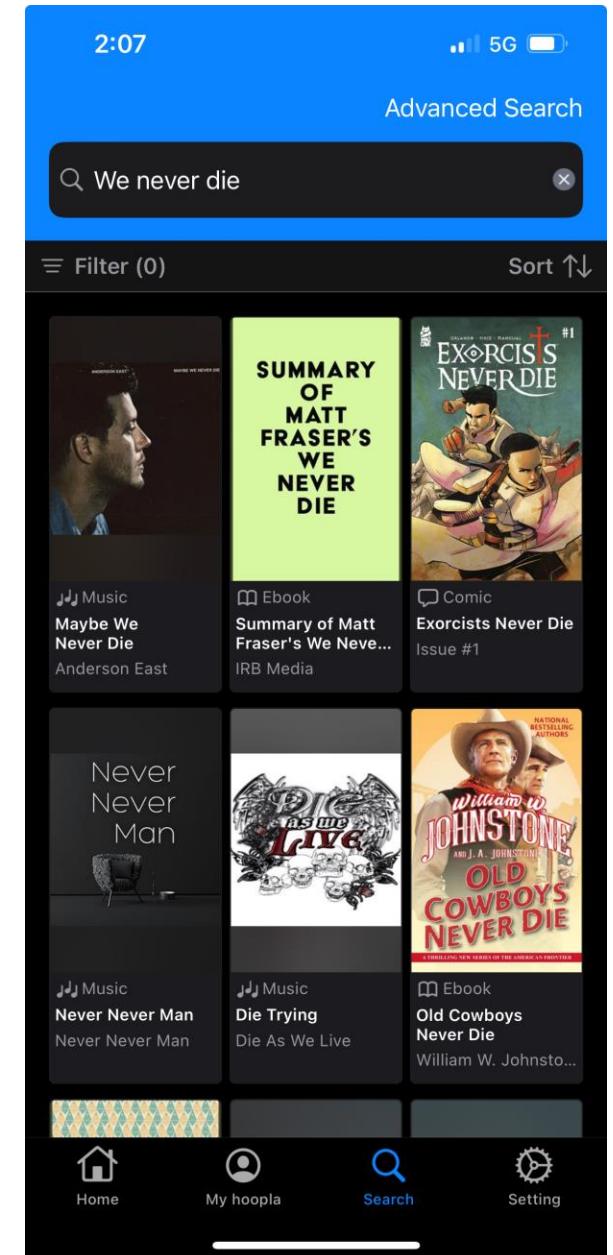
Amazon & Content Farms

- Content Farms are flooding Kindle direct with
 - Celebrity Bios after death of person
 - Knock off travel guides, cookbooks and basic children's non-fiction are common
 - Information either not specific enough or just false
 - Title often one or two word off from legitimately researched and authoritative work
 - “Summary and Analysis” of popular titles
 - Often there is no analysis just AI summary maybe edited by a human.

Digital Content



- LLMs have been feed large databases of titles.
- Content Farms can use generative AI to mass produce junk titles and flood the marketplace.
- IRB Media claims to be a publishing company without a website or address.
- Draft2Digital is self publishing service
- Lite Press claims to be a publishing company without a website or address.

Hoopla can generate a report that lists taggable AI content and summaries.

This includes audiobooks that are read, but not generated by AI.

You can block these titles. However, you may choose to keep some (Harlequin Audio, for example).

Selection Tips

Not every topic has a published book.

Sometimes the best resource is a DVD or a website.

Be wary of out of copyright works.

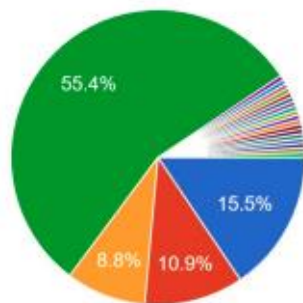
PCC AI Task Group Updates

- Resources from Program for Cooperative Cataloging (PCC)
- FAQ: Cataloging of Resources Generated Using AI issued on February 2, 2024
 - This is for treatment for works recommendation to treat AI software as a “related work” (730) and the person as an editors (700). A person may also author (100) parts of the work.
- Final Report published on May 9th
 - Created
 - PCC Wiki updated with AI resources
 - Found
 - AI is not an easy fix to save money
 - Lack of resources to evaluate AI sales promises
 - Tools used fail or had mild success
 - Establish new group to:
 - Statement of Principles for AI in metadata and cataloging
 - Best Practices document
 - Training resources developed

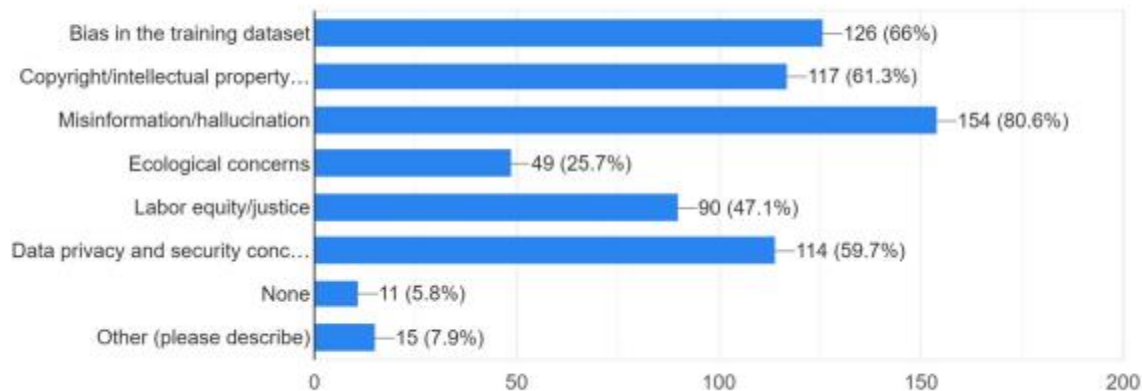
